

## 2010 TRACK USAGE PROCEDURE ---- (GVKC MEMBERS ONLY)

**To use the track on an unscheduled day during the race season, you need to sign the track usage procedure form and send it along with the fee of \$75.00 plus any additional required fees noted below to: Al Gutberlet 985 Pear Tree Lane, Webster, NY 14580 (585)872-1973.**

**NO MOTORS CAN BE STARTED BEFORE 11:00 AM AND MUST SHUT OFF BY 5PM.**

When you first arrive at the track, open the restrooms and turn on the water by turning on the circuit breakers just inside the doors in the men's room. All the breakers should be in the on position.

You should walk the track to make sure there is no debris.

Only two karts on the track at once and there should always be someone in the pit spotting in case of emergency. Remember its your responsibility for safety!

You have use of the facility from 10AM to 6PM, motors only 11 am - 5pm. Everyone must be off the grounds by 6PM.

Before you leave you must turn everything off that you have turned on and lock everything you have unlocked.

If anyone is found driving on the track inappropriately or if you are caught driving anything but a recognized safe go-kart (no cars, motorcycles etc.), it may result in penalties for the person who has officially requested to use the track, and/or a loss of the privilege to use the track in the future.

**I have read and understand the above regulations and responsibility that I am assuming when using the track. By signing this form I also agree to subsequently submit (either mail to the above address or bring to the track at the next racing event, whichever would allow the forms to be received sooner) completed insurance forms for all people that are at the track on the day noted. All minors must have a minor release form submitted (if not on file with the club for the current year) along with the adult and minor release waivers for the day. All forms will be made accessible at the track for completion. Completed forms must be received by the next race day or future use of the track may be denied.**
